Catlin met with Treatment Plant employees and Engineer Smith to review. There are a few changes and will be ready for the September meeting.

GENERATORS - NOTICE TO PROCEED

The cost is more than anticipated so this will be addressed at budget time.

GREENSPACE UPDATE

Reiter clarified a misunderstanding about the greenspace at Joseph Davis State Park. The Town is not selling greenspace there.

The greenspace in discussion is located between housing lots in the Lewistown Estates. This consisting of Raymond, Powell, Mary Lane etc.. The land is not accessible. There has already been many encroachment on the greenspace.

The Town would need to declare the property in-excess, and then bid it out to interested property owners.

Dowd said hopefully the land was not designated park land; if so the Town would need to go to the State Legislature to have this approved.

NATIONAL GRID - WATTAGE FOR FIXTURE - NORTH KLINE ROAD

The Town received a letter from National Grid stating Pole #7-1, at the corner of North Hewitt and Edna Drives, has a 100 watt HPS bulb. The Town is charged for a 70watt HPS. National Grid needs to know what wattage should be put in there.

Palmer MOVED to keep Pole #70-1 North Hewitt Drive at the corner of Edna Drive, at 70 watts HPS, Seconded by Bax and Carried 5 – 0.

CROSSWALK AND LIGHTING REQUEST – MODEL CITY ROAD

The Town received a letter from Modern Corporation requesting a crosswalk from their parking lot, on the east side of Model City Road, to the plant. Modern also requests the Town improve the street lighting.

Janese has placed "Pedestrian Crossing" signs on the east and west sides of Model City Road. Reiter asked Janese to discuss this with Modern.

Reiter does not feel it is the Towns responsibility for the crosswalk painting of Model City. It is for their employees.

TRUCK NOISE - CREEK ROAD

Signs were posted regarding noise, but they have since disappeared. Janese to contact New York State DOT to have them replaced.
