### **SUPERVISOR BRODERICK**

Broderick read a letter form Dep. Bldg. Insp. Zimmerman regarding a street name change:

To the Town of Lewiston Town Board, the request was made to the Town of Lewiston, by the new owner of the Lewiston Heights Luxury Estates subdivision to change the name of Mountain Ash Lane (a stub road off Country Club Trail) to Augusta Lane. It is my understanding, the Town Board tabled the decision upon the approval of Police, Fire, and Highway Department approval. Since the last meeting, Police, Fire and Highway have all given their blessing and have no issue with the proposed name change. We have reached out to Niagara County Real Property as well as the Niagara County Sheriff's Department Communication Division and made sure there is no special information needed on their end and at this point, all we need to submit to them is the Town of Lewiston Town Board approval documenting the change.

Once the Town receives approval, the Building Department will work with the Town Clerks' Office to make sure we get the information to Niagara County Real Property as well as the Niagara County Sheriff's Dispatch Center to update in a timely fashion. If any additional information is needed, please reach out to Zimmerman in the Building Dept. We will also work with Highway once all is official to update the signage on that street corner.

Broderick would like to thank Zimmerman for his diligence on this matter. He knows it is important to the gentleman who owns the property. He acknowledges that when the request was made at the last meeting, if it weren't for Zimmerman, this would have ended up at the "bottom of the barrel" by Wednesday or Thursday. Zimmerman pulled this right back to the top and made all the necessary phone calls. Broderick said there is intention to change all the road names off Country Club Trail to be named after popular golf courses.
